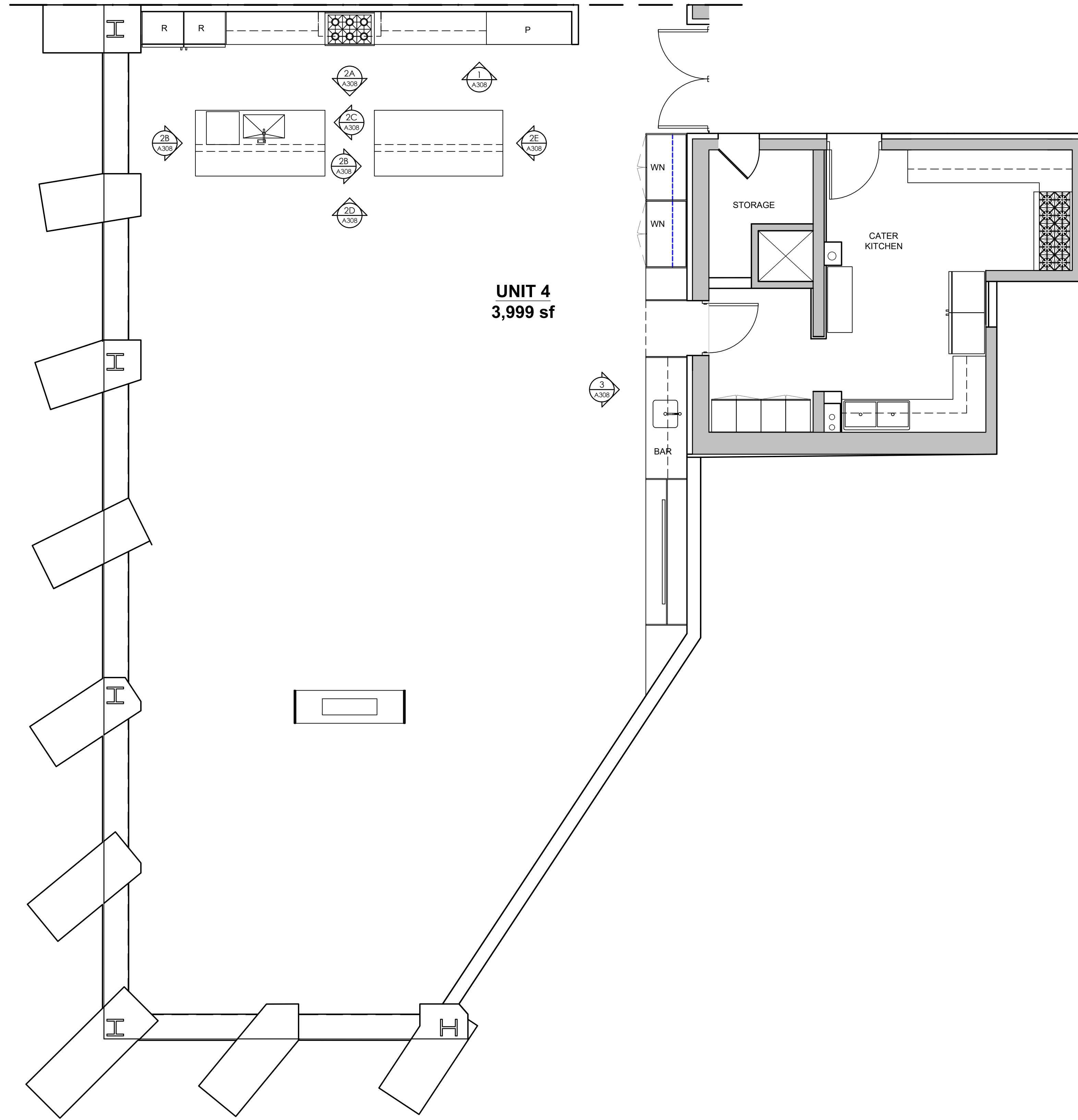


2 ENLARGED PLAN - PARTIAL UNIT 4

1. ALL DIMENSIONS TO BE TAKEN FROM FACE OF FINISH WALL U.N.O.
2. ALL NEW WALLS ARE TO BE SOUND PARTITIONS, UNLESS OTHERWISE NOTED. REFER TO PARTITION TYPES ON SHEET A1.
3. JOINTS ABUTTING EXISTING WALLS ARE TO BE TAPED AND FINISHED.
4. COORDINATE NEW DATA & PHONE LOCATIONS W/ OWNER.
5. CONTRACTOR SHALL PROVIDE BLOCKING AS REQUIRED FOR ALL MILLWORK & EQUIP INSTALLATION.
6. PROVIDE MOISTURE RESISTANT GYP BOARD BEHIND TOILETS AND SINKS & ALL WET WALL LOCATIONS. PROVIDE FRP AS LISTED.
7. ALL WALLS SHALL RECEIVE PAINT FINISHES U.N.O.
8. ALL DOORS TO BE 1-3/4" THICK. ALL FRAMES TO BE 16ga. PROVIDE ANCHORAGE TYPE TO SUIT WALL CONSTRUCTION. ALL FRAMES TO OVERLAP WALL FINISH. PROVIDE (2) 2x6 STUDS AT JAMBS IN GYPSUM BOARD WALLS.
9. FINAL DOOR HARDWARE FUNCTION SHALL BE VERIFIED/ COORDINATED WITH OWNER. ALL DOOR HARDWARE SHALL BE ADA COMPLIANT LEVER TYPE.
10. ALL MECHANICAL, PLUMBING & ELECTRICAL DESIGN & LAYOUTS SHALL BE PROVIDED BY OTHERS- UNDER SEPARATE COVER.
11. PROVIDE FIRE EXTINGUISHER CABINETS, SEMI-RECESSED, AT EVERY FLOOR, EVENLY DISTRIBUTED. LOCATIONS TBD.
12. ALL ELECTRICAL DRYERS TO BE VENTLESS.
